# Social value



- Our broadest impact is more than the sum of our parts
- Our impact is broader than our planned outcomes
- Reflecting and reporting on our Social Value and impact is crucial to our sustainability and credibility

## A brief overview of what we did

- 10 workshops delivered – covering social value meaning (what it is, what it isn't), measuring social value, responding to social value tender questions, data collection speakers from social value exemplars
- Numerous 1:1 workshops how your services create impact, starting out in measuring social value
- Visits to organisations
- Support with impact measurement

## Why we did social value

- *“The pandemic meant that new ways of working had to be mobilised rapidly. Historic tensions between the NHS and communities had to be navigated. The third sector played a huge role in mobilising and coordinating during pandemic.”*

- The question is, post pandemic will we return to the status quo

# Why we did social value

- *‘Because there are those who suffer disproportionately, have poorer health outcomes, experience challenges engaging with health services as currently provided..’*
- The project aims to improve the engagement of civil society with statutory health providers and commissioning as a way of effecting system change in the way health and social care policy is made and services delivered.
- To effect system change in the way health and social care policy is made and service delivered
- To strengthen the capacity of VSC organisations within its area.

# A snapshot of Bromley's voluntary & community sector

- Circa 800 registered charities circa 500 operate locally \*
- 27% of Bromley's VCSE work with older people
- 22% work with people living with mental health conditions
- 19% work with people with disabilities
- 51% have said there was a higher or much higher demand for services during the pandemic
- What will be the next trigger of demand for wellbeing services?



# A snapshot of Bromley's VCSE cont'd

- Bromley Third Sector Enterprise –
- Partnership of 5 local charities managing health contracts £11m over six years
- 64 local organisations associate members delivering health & wellbeing services
